



The contest (the "Contest") is governed by the following rules and regulations:

Contest Rules and Regulations (the "Contest Rules"):

NO PURCHASE NECESSARY. CONTEST IS OPEN ONLY TO LEGAL RESIDENTS OF THE FIFTY (50) UNITED STATES ("US"), DISTRICT OF COLUMBIA ("DC") AND CANADA, EXCLUDING QUEBEC, RHODE ISLAND, AND FLORIDA, WHO ARE OF THE AGE OF MAJORITY OR OLDER IN THEIR STATE/PROVINCE/TERRITORY OF RESIDENCE. The Contest Period:

The Sponsor:
